#### ADVERTISEMENT FOR THE APPOINTMENT OF REGISTRAR

McPherson University, Seriki Sotayo hereby declares that the post of the Registrar will become vacant by 31<sup>st</sup> July, 2017. The University's Council hereby invites applications from suitably qualified candidates for the position. Interested applicants are requested to note the following information about the University and post.

#### THE UNIVERSITY

McPherson University is a licensed private Christian institution established by the Foursquare Gospel Church in Nigeria. It was granted an operational license by the Federal Government on 28<sup>th</sup> February, 2012 and started operating in October, 2012. The University has graduated its first set of students and commenced its fifth Academic Session in October, 2016 (i.e. 2016/2017). The University which is fully residential is committed to producing future leaders who are God-fearing, creative and resourceful. The University's motto is **Knowledge, Integrity and Service.** 

The Vision of the University is "to build a People of Excellence and Integrity for Service".

Its Mission is "to provide qualitative, functional and sound education with Godly virtues that will prepare men and women for leadership and positive impact on the Society".

The University hereby invites applications from suitably qualified candidates for the post of Registrar.

### THE POSITION

The Registrar is the Chief Administrative Officer of the University and shall be directly responsible to the Vice-Chancellor for the day-to-day administration of the affairs (other than the financial affairs) of the University.

By virtue of his/her position, the Registrar is the Secretary to the University Governing Council, Senate, Convocation and Congregation of the University. The Registrar is also a Principal Officer of the University.

#### SALARY AND CONDITION OF SERVICE

The post of the Registrar is tenure track. The successful candidate shall hold office for a single term of five (5) years on such terms and conditions as may be specified in the letter of appointment.

The salary and allowances attached to this position are very attractive. The University runs a salary scale that compares with what obtains in Public Universities in Nigeria.

## QUALIFICATION AND EXPERIENCE

The candidate for the post of Registrar must possess:

- A good first degree with a minimum of Second Class (Honours) from a recognized institution. Possession of a Higher Degree as well as membership of recognized professional bodies will be an advantage;
- At least fifteen (15) years of relevant post-qualification experience, ten of which must be in the University system and at least four (4) of which must have been at a level not below Deputy Registrar or its equivalent;
- An evidence of having served in the NYSC or evidence of exemption;
- A high integrity and moral standard;
- An excellent interpersonal relations;
- Exceptional leadership qualities to be able to motivate subordinates for the achievement of institutional goals
- Demonstrable evidence of an exemplary Team Leader with clear mentorship skills and plans;
- An excellent physical and mental health and must be ICT compliant with a high level of Computer literacy.
